**PERMIT TO ALLOW MINOR USE OF AN AGVET CHEMICAL PRODUCT**

**FOR CONTROL OF TWO-SPOTTED MITE ON MAIZE AND POPCORN**

**PERMIT NUMBER – PER81373**

This permit is issued to the Permit Holder in response to an application granted by the APVMA under section 112 of the Agvet Codes of the jurisdictions set out below. This permit allows a person, as stipulated below, to use the product in the manner specified in this permit in the designated jurisdictions. This permit also allows any person to claim that the product can be used in the manner specified in this permit.

## CONDITIONS OF USE

### Product to be used:

ALL REGISTERED PRODUCTS containing:

18 g/L ABAMECTIN as their only active constituent and

36g/L ABAMECTIN as their only active constituent.

### Directions for Use:

Crop	Insect Pest	Rate
MAIZE POPCORN	Two-spotted mite ( <i>Tetranychus urticae</i> )	<b>Abamectin 18g/L product</b> 300 mL product / ha  <b>Abamectin 36g/L product</b> 150 mL product/ha

### Critical Use Comments:

- Apply during final stages of crop development when mites become a problem causing early drydown.
- Monitor crops regularly and apply when 10 or more mites are observed per leaf.
- Apply in sufficient volume to penetrate the plant canopy and evenly cover plant surfaces.
- For aerial spraying, apply in a minimum water volume of 30 L/ha.
- Allow at least 7 DAYS between applications (if required).
- DO NOT apply more than two (2) applications per crop.

### Withholding Period:

Harvest:

DO NOT harvest for 28 DAYS after final application.

Grazing:

DO NOT allow livestock to graze or cut for stock food for 28 DAYS after final application.

Observe restraints and restrictions for tank mix products.

### Jurisdiction:

ALL STATES except VIC.

Note: Victoria is not included in this permit because their 'control-of-use' legislation means that a permit is not required to legalise this off-label use in that state.

### Additional Conditions:

PERSONS who wish to prepare for use and/or use products for the purposes specified in this permit must read, or have read to them, the DETAILS and CONDITIONS of this permit.

This PERMIT provides for the use of a product in a manner other than specified on the approved label of the product. Unless otherwise stated in this permit, the use of the product must be in accordance with instructions on its label.

### Export of treated produce:

To allow produce from treated plants to be supplied or otherwise made available for human consumption the APVMA has established a temporary Maximum Residue Limit (MRL) for abamectin on maize at T\*0.01mg/kg. This limit applies only to produce marketed and consumed in Australia. If treated produce is to be exported, due account should be taken of the residue definition and residue limits/import tolerances of importing countries, and that any residues must not exceed those requirements of the importing country.
